### **Risk and Waiver of Liability For Summer Camp Program Including Coronavirus/COVID-19**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person and surface to person contact, including individuals without disease symptoms. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited or limited the congregation of groups of people in addition to wearing personal protective equipment.

The health and well-being of our coaches, staff and students remains our top priority. In order to minimize the risk of COVID-19 entering our environment and spreading amongst our community, we will only allow coaches and staff assigned to work and participating students to be in our facility. Parents wishing to remain on site can use outdoor common areas or the parking lot to wait for their daughter. Students waiting to attend a session will need to wait outside while maintaining social distancing from others. No person presenting symptoms or testing positive for COVID-19 shall be allowed to enter or remain on the property at any point.

Furthermore, all participants in sponsored activities at **Assumption High School** must agree to abide by the following guidelines: **SEE ADDENDUM: (Attached)**

**Assumption High School** (hereafter referred to as the "AHS") has put in place numerous preventative measures and enhanced cleaning protocols to reduce the likelihood of spreading COVID-19 in our facilities however, AHS cannot guarantee that you or your daughter will not become infected with COVID-19. Further, attending sponsored activities at AHS could increase your risk and your daughter risk of contracting COVID-19.

By signing this agreement, I agree to allow my daughter to participate in athletic activities offered by Assumption High School and acknowledge my daughter is fit for the activity in which she is attending.

In addition, by signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily agree to the participation terms described above and assume the risk that my daughter, my guests and I may be exposed to or infected by the COVID-19 while at AHS and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

I understand that the risk of becoming exposed to or infected by COVID-19 at AHS may result from the actions or omissions of myself and others, including, but not limited to, AHS coaches, employees, volunteers, and program participants and their families. I voluntarily agree to indemnify a hold harmless AHS and personally assume all of the foregoing risks and accept sole responsibility for any injury (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that my daughter, my guests or I may experience or incur in connection with our attendance at AHS or participation in AHS programming.

**On my behalf, and on behalf of my daughter, I hereby release, discharge, covenant not to sue, and hold harmless AHS, its employees, agents, owners and representatives, of and from any and all liability for any injuries, illness, and loss, including all liabilities, claims, actions, damages, costs, or expenses of any kind arising out of, directly or indirectly, from my child's or children's participation in Assumption High School's summer camp program.**

**All claims and disputes arising under or relating to this Agreement are to be settled by binding arbitration, and not by a jury trial, in the commonwealth of Kentucky or another location mutually agreeable to the parties. An award of arbitration may be confirmed in a court of competent jurisdiction.**

I understand and agree that this release includes all Claims based on the actions or, omissions, of the AHS, its employees, coaches, agents, owners and representatives, whether COVID -19 related or not, and whether a COVID-19 infection occurs before, during, or after participation or presence in any AHS activity or in any AHS facility.
